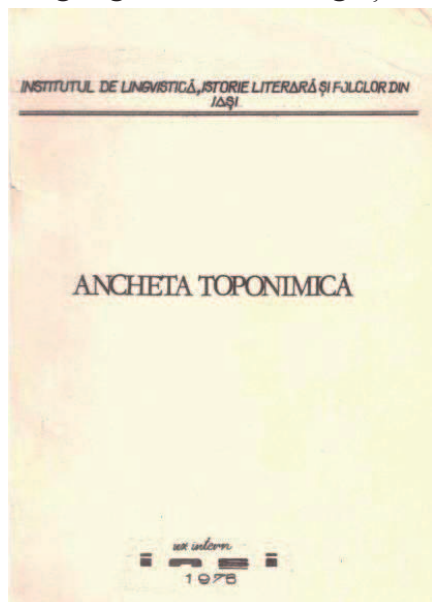


## Dragoș Moldovanu, Professor and Scientist

An author and a specialist concerned with Romanian linguistics, general linguistics, with toponymy, stylistics and literary semiotics, with Romance language studies, Dragoș Moldovanu began his career as a scientific researcher in



1964 at the Centre of Linguistics, Literary History and Folklore of the Romanian Academy, Iași branch, today the “A. Philippide” Institute of Philology. Here, he conducted research in the field of lexicology. Soon, he established the Department of Toponymy, given his preoccupations in the domain of Romanian toponymy: he developed a methodology of applied research, of structural principles of toponymic lexicography (embodied in the grouping of toponyms by fields, according to relevant schemes in point of formation and evolution); he drew up a corpus of popular geographical terms, a questionnaire of 1,045 questions and a research fund based on surveys –

either direct or indirect, in Moldova; he wrote the monograph *Toponimia personală românească în perspectivă diacronică* / ‘Romanian personal toponymy from a diachronic perspective’ (a contract with the Institute of Geography of Bucharest).

He was awarded the PhD title for the thesis *Influențe umaniste și baroce în stilul lui Dimitrie Cantemir: structurile sintactice dislocate* / ‘Humanist and baroque influences in the style of Dimitrie Cantemir: dislocated syntactic structures’.

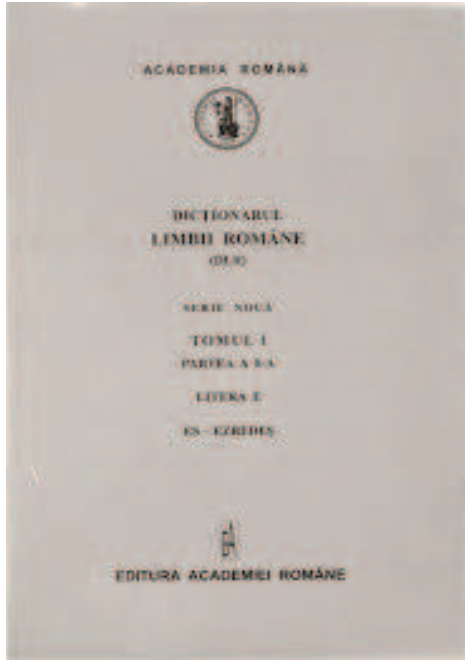


From 1976 to 1991 he was head of the Department of Toponymy, editor and coordinator of the theme of national importance *Tezaurul toponimic al României. Moldova* / ‘The toponymic treasure of Romania. Moldova’, involving a great number of researchers and academics (Faculty of Letters of “Alexandru Ioan Cuza” University of Iași, the Pedagogical Institutes in Bacău, Galați and Suceava) and high school teachers. All collaborators were initiated into the technique of field research, by collective

surveys in various counties of Moldova.

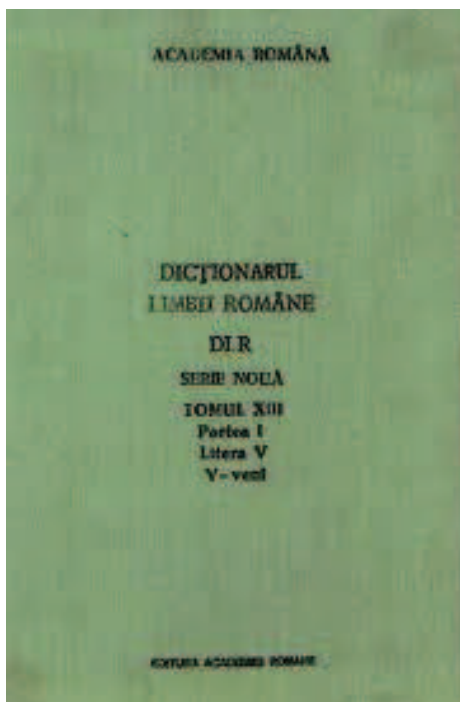
From 1991 to 1992, he was a scientific researcher II, and from 1992 to 1997, a scientific researcher I, doctor, carrying out research in the field of onomastics, history of the Romanian language, as well as history of the Romanian

literary language, stylistics or general linguistics. He coordinated the project of the Romanian Academy *Tezaurul toponimic al României. Moldova*.



From 1997 to 2007 he was a Professor at the Faculty of Letters of “Alexandru Ioan Cuza” University of Iași and a scientific researcher I, part-time, at the “A. Philippide” Institute of Romanian Philology. As a professor, he delivered lectures on the history of the Romanian language, history of the Romanian literary language, stylistics of the Romanian language, Romanian toponymy, general linguistics and Indo-European studies. He elaborated the volume *Toponimia Moldovei în cartografia europeană veche, cca 1395-1789*/ ‘Toponymy of Moldova in old European cartography, approx. 1395-1789’, from the series *Tezaurul toponimic al României. Moldova*.

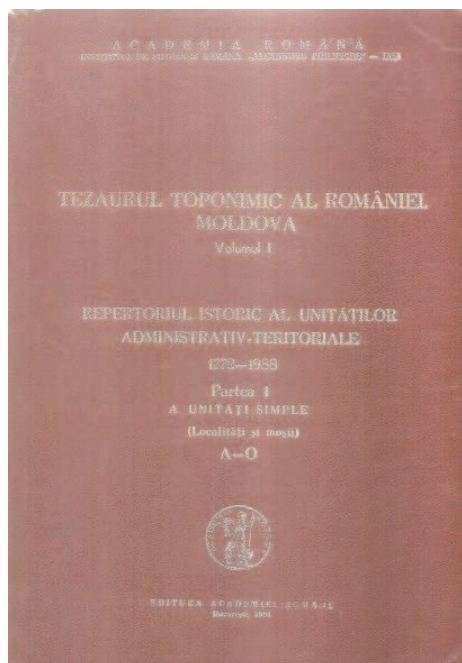
Founder of a department at the “A. Philippide” Institute of Romanian Philology in Iași, initiator of a research direction, based on a new theory of language, a new method of toponymic survey and new lexicographical rules, applicable to the structural study of toponymy, a competent specialist, a specialist in a discipline at the crossroads of several fields: general linguistics



(theory of proper names), lexicography, history of the Romanian language, as well as history of Slavic, Turkic, Germanic languages, history as such, geography, historical geography, he has approached a variety of key issues for toponymy, lexicology, lexicography, history of language, history and geography simultaneously, offering solutions.

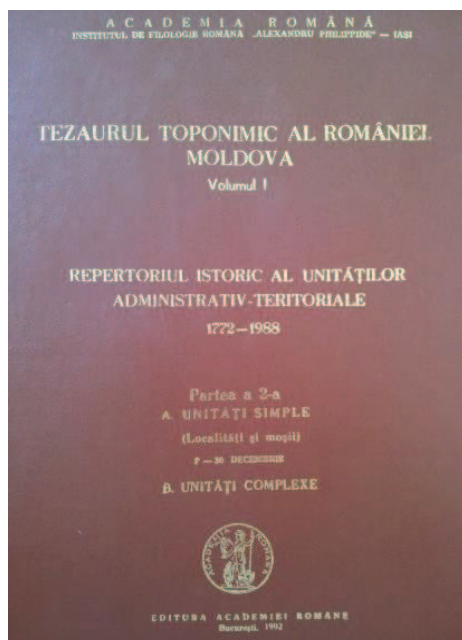

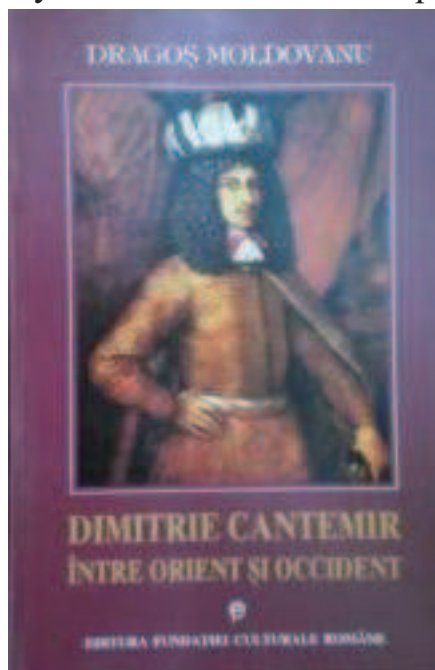

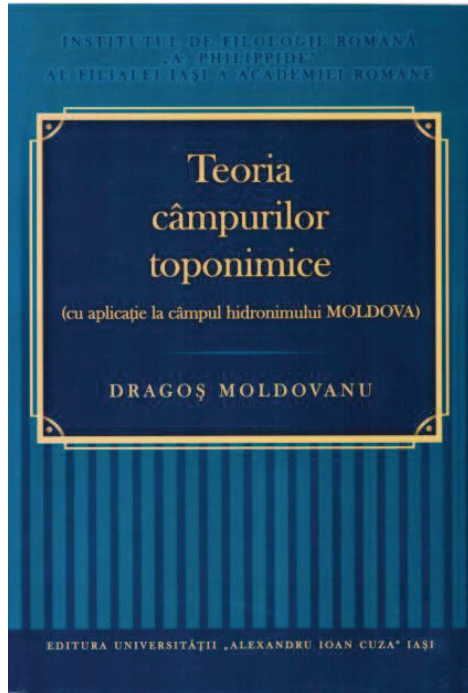

Dragoș Moldovanu is an expert in state-of-the-art scientific activities performed in research teams. The linguist’s works are highly valued and have received awards. For *Tezaurul toponimic al României. Moldova*, vol. I, part 1, Editura Academiei Române, București, 1991, he received the award “Timotei Cipariu” of the Romanian Academy in 1993. At the International Book Fair in Romania, Iași, in 2002, *Tipologia stilului lui Dimitrie Cantemir din perspectiva figurii dominante*/ ‘The typology of Dimitrie Cantemir’s style from the perspective of the dominant figure’, published at Editura Universității „Alexandru Ioan Cuza”, Iași, 2002, was deemed the best academic book. In 2012 he received the second award “Timotei Cipariu” of the Romanian Academy for *Teoria câmpurilor toponimice (cu aplicație la câmpul hidronimului*

*MOLDOVA*)/ ‘The theory of toponymic fields (as applied to the field of the hydronym MOLDOVA)’, published at Editura Universității „Alexandru Ioan Cuza”, Iași, 2010.

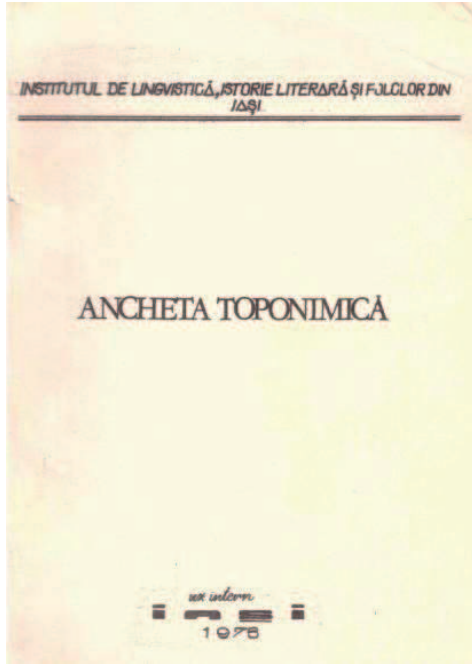
From 2007 to 2013, he coordinated *Micul dicționar toponimic al Moldovei, structural și etimologic Partea 1. Toponime personale/* ‘Little toponymic dictionary of Moldova, structural and etymological. Part 1. Personal toponyms’ (national priority project of the Romanian Academy), representing a volume of the series *Tezaurul toponimic al României. Moldova*. He developed a model (overview, rules of editing and samples of articles), made the review of the drafts of the team members (with many essential personal contributions at all levels of the lexicographical microstructure), presented theoretical and methodological innovations individualizing the dictionary in relation to similar European works.

With over 50 years of activity, a laborious researcher, professor and scholar, Dragoș Moldovanu occupies an important place in Romanian linguistics, as a model of professional dedication.

## Le chercheur et le professeur Dragoș Moldovanu

Spécialiste ayant des préoccupations dans le domaine de la linguistique roumaine, de la linguistique générale, de la toponymie, de la stylistique et de la sémiotique littéraire, de la romanistique, Dragoș Moldovanu commence sa



carrière de chercheur scientifique en 1964 au Centre de linguistique, histoire littéraire et folklore de l'Académie roumaine, filiale Iasi, l'actuel Institut de philologie A. Philippide. Il y déploie des activités dans le domaine de la lexicographie en constituant rapidement le Département de toponymie. Vu ses préoccupations dans le domaine de la toponymie roumaine : il élabore une méthodologie de la recherche applicative, certains principes structurels de la lexicographie toponymique (matérialisés dans le regroupement des toponymes sur des champs, selon des schémas pertinents pour leur processus de formation et d'évolution); il édifie un corpus de termes géographiques

populaires, un questionnaire de 1045 questions et un fond documentaire issu des enquêtes – directes et indirectes de la Moldavie ; il rédige la monographie *Toponimia personală românească în perspectivă diacronică* (thème de contrat avec l'Institut de géographie de Bucarest).

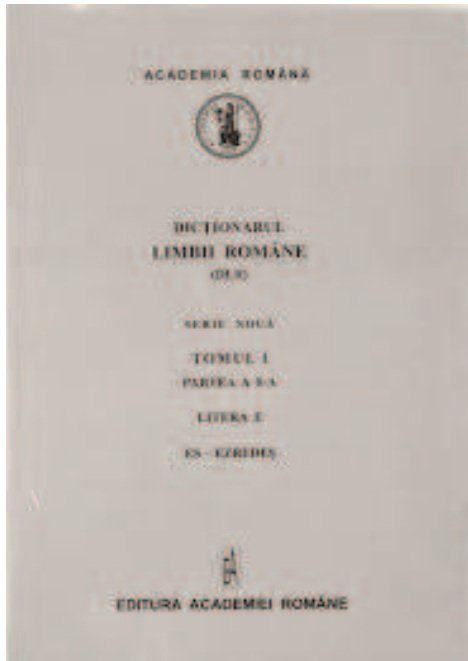


Il devint docteur ès philologie avec la thèse *Influențe umaniste și baroce în stilul lui Dimitrie Cantemir: structurile sintactice dislocate*.

Dans la période 1976-1991 il est le chef du Département de toponymie, rédacteur et coordonateur du thème d'importance nationale *Le trésor toponymique de la Roumanie. La Moldavie*, dont la réalisation a entraîné un grand nombre de chercheurs et des professeurs de l'enseignement universitaire (la Faculté des lettres de l'Université « Alexandru Ioan Cuza » de Iasi, les Instituts pédagogiques de Bacău, Galați et Suceava) et de l'enseignement pré-universitaire. Tous ses collaborateurs ont été initiés à la technique de

la recherche sur le terrain, par des enquêtes collectives en différents départements de la Moldavie.

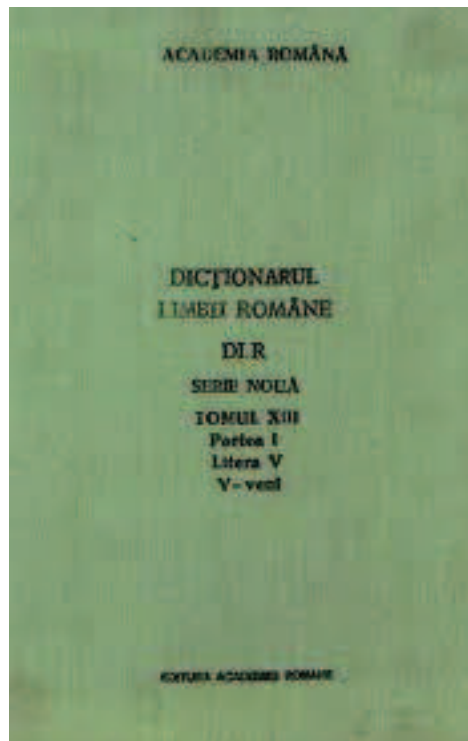
Depuis 1991 et jusqu'en 1992 il est chercheur scientifique II<sup>ème</sup> classe, et de 1992 à 1997, il devient chercheur scientifique I<sup>ère</sup> classe, docteur, en déployant des activités de recherche dans le domaine de l'onomastique, de l'histoire de la langue roumaine, mais aussi de l'histoire de la langue roumaine littéraire, de la stylistique ou de la linguistique générale. Il dirige le projet de l'Académie roumaine *Le trésor toponymique de la Roumanie. La Moldavie*.



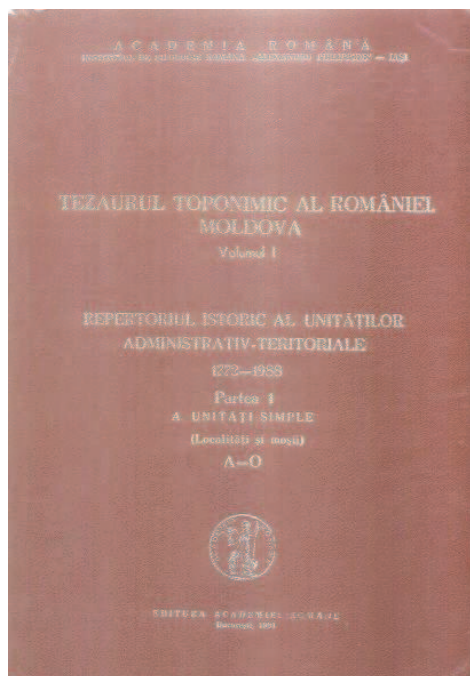
Pendant la période 1997 – 2007 il est professeur universitaire docteur à la Faculté des lettres de l'Université « Alexandru Ioan Cuza » de Iasi, et chercheur scientifique I<sup>ère</sup> classe à temps partiel à l'Institut de philologie roumaine « A. Philippide ». En tant que professeur, il a dispensé des cours d'histoire de la langue roumaine, d'histoire de la langue roumaine littéraire, de stylistique de la langue roumaine, de toponymie roumaine, de

linguistique générale et indo-européistique. Il élabore le volume *Toponimia Moldovei în cartografia europeană veche, cca 1395-1789*, de la série du *Tezaur toponimic al României. Moldova*.

Fondateur d'un département à l'Institut de philologie roumaine « A. Philippide » de Iasi, initiateur d'une direction de recherche, basée sur une nouvelle théorie linguistique, sur une nouvelle méthode d'enquête toponymique et sur de nouvelles normes lexicographiques, applicables à l'étude structurale de la toponymie, il est spécialiste d'une grande autorité et compétence, spécialiste d'une discipline à la frontière de quelques domaines : linguistique générale (la théorie du nom propre), lexicologie, histoire de la langue roumaine, mais aussi histoire des langues slaves, turques, germaniques, histoire proprement-dite, géographie, géographie historique. Il approche une diversité de problèmes dont il offre des solutions, des problèmes essentiels pour la toponymie, la lexicologie, la lexicographie, l'histoire de la langue, l'histoire et en même temps la géographie.

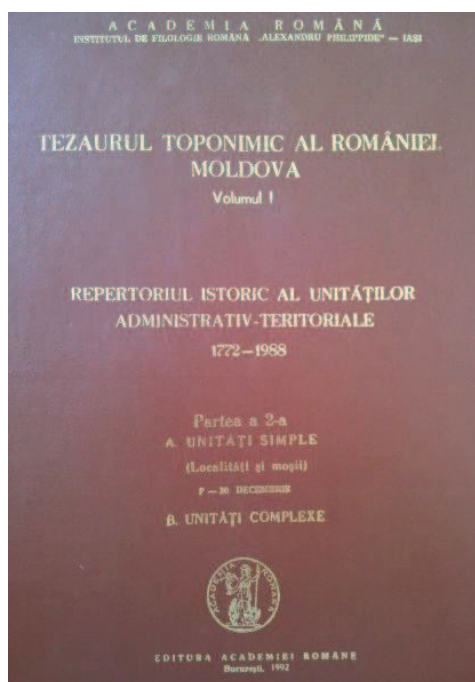

Dans la période 2007-2013 il est le coordonnateur du dictionnaire *Micul dicționar toponimic al Moldovei, structural și etimologic* Partie 1. *Toponime personale* (projet national prioritaire de l’Académie roumaine), un volume de la série du *Tezaurul toponimic al României. Moldova*. Il y élabore une maquette (présentation générale, normes de rédaction et échantillons d’articles), fait la révision générale des écrits des membres du collectif (avec de nombreuses contributions personnelles essentielles à tous les niveaux de la microstructure lexicographique), en réalisant des innovations théoriques et méthodologiques qui individualisent le dictionnaire par rapport aux travaux européens similaires.

Avec une activité de plus de 50 ans, chercheur assidu et professeur érudite, Dragoș Moldovanu occupe une place privilégiée dans la linguistique roumaine, en constituant un modèle de dévouement professionnel.
